Entries in the Sauce category DO NOT have to be prepared on site. You may cook your sauce at home, then bring it for judging. Sauce judging will be done in **one round** and will be blind judged at 12:45 – 1:00 PM A **four-ounce** cup with lid will be given to each entrant at Team Registration. Each team is allowed to enter multiple Sauce entries. Cups should be full when brought to blind judging. Do not place any marks on the cup or lid.
