- Each entrant **must fill out the separate BRISKET Challenge Only application.**
- **BRISKET MUST** be cooked on any type grill/smoker including charcoal, wood, or pellet.
- Turn in container will be provided. There shall be nothing in the container except the BRISKET. No garnish, gravy, topping, etc. of any kind is allowed.
- The BRISKET will be judged using the standard GBA comparative judging procedures.
